Board Recommendations—Updates to Standing Rules — Vote at General Meeting

Board Resolution 1— Revision to Standing Rule 18—General Meetings Classes

Regarding our “after-meeting paint-ins,” the board has proposed a resolution that NWDA pay the teacher direct \$150.00, and members (and guests who can attend 2 meetings before joining our chapter) can take the workshop at no charge.

The person teaching the workshop is responsible to get permission from the artist (unless the workshop is published in the Decorative Painter magazine) and arrange for members to purchase pattern packets and or any special supplies.

Reasoning:

Previously, everyone paid the teacher, which does not work with Zoom workshops. We decided to inquire with the SDP last September if we could offer our paint-ins at no charge to our members and we were told that this is okay since we are supporting our mission to promote decorative painting.

Board Resolution 2 - Revision to Standing Rule 1— General Meeting Days

The board has met and is proposing to change the chapter meeting day to either the 1st Saturday or 3rd Saturday. Currently we are meeting the 2nd Saturday in January, March, May, July, September, and November. We have had a request from the Tugboats chapter if we could change our date to the 1st or the 3rd Saturday of those months. The church that Tugboats meets at has unfortunately changed their meeting date to the second Saturday every month. Several NWDA members are in Tugboats as well as Raindrops and we would like to be able to support each other. Also, Monica who is on the board, cannot do both meetings on the same day so the board would like to support her. If she was unable to then we'd have to find a replacement for her board position.

There are **pros** and **cons** to the 1st and 3rd dates. The benefit to changing to the first Saturday is that Raindrops also meets the first Saturday (opposite months) and that would leave open the third and fourth Saturdays for workshops. On the other hand, if we pick the 1st Saturday then we have a potential conflict with 4th of July and Labor Day holidays depending on the year. The 3rd Saturday has no conflicts with holidays however it does have a few immediate conflicts with Tugboat and Raindrop Zoom seminars this year. We are however planning on recording our “after-meeting paint-ins” which someone has another commitment.

We are asking for a majority vote at the meeting to change the date and if approved then to pick which date, the 1st or 3rd Saturday. Also, the board would like to start our meetings in the future at 10:00 AM to allow more time for painting, so this also will need a vote. When we are back in person the doors would be open at 9:30 with the meeting starting at 10:00. We are hoping to be able to have hybrid in-person meetings in the future with a Zoom option for members that can't meet in person. **(Cont Page 7)**

Board Resolution 2 - Revision to Standing Rule 1— General Meeting Days (Cont Page 6)

We will have five minutes for discussion and then vote through the Chat feature for numbers 1, 2, 3, or 4 and A or B.

1. Keep meeting the same (2nd Saturday) OR
2. Change meeting to 1st Saturday OR
3. Change meeting to 3rd Saturday OR
4. Change meeting date - no preference as to 1st or 3rd Saturday.

- A. Keep meeting time at 10:30 am
- B. Change meeting time to 10:00 am

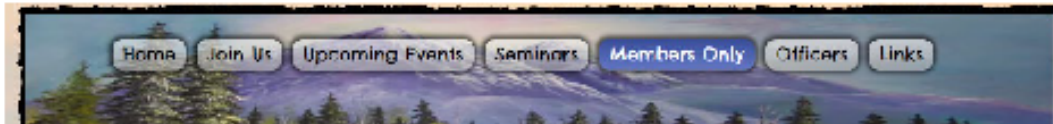
